- ☐ Get help accessing medical services – LA County Department of Public Health, Medication Assistance (DPH)
 - Prescription medication refills
 - Service referrals
- ☐ Get Medi-Cal – LA County Department of Public Social Services (DPSS)
- ☐ Get help with mental health resources – LA County Department of Mental Health (DMH)
- ☐ Get help for people who are older or have disabilities – LA County Aging & Disabilities Department (AD)
 - Service referrals
 - Caregiver support
- ☐ Get long-term care for veterans and spouses – California Veterans Affairs (CalVet)

Housing

- ☐ Get help with housing – LA County 211
- ☐ Find temporary housing – LA County Department of Public Social Services (DPSS)
- ☐ Get help with housing protections – LA County Department of Consumer & Business Affairs (DCBA)

Social services

- ☐ Get help with child support questions – LA County Child Support Services Department (CSSD)
- ☐ Get VA benefits – California Veterans Affairs (CalVet)

Individual assistance

- ☐ Learn about Individual and Household Program grant extensions – California Department of Social Services (CDSS)

Replace your personal documents

- ☐ Replace your birth, death, and marriage certificates (fees waived) – California Department of Public Health (CDPH) and LA County Registrar Recorder/County Clerk (RR/CC)
- ☐ Replace your identity and car documents – Department of Motor Vehicles (DMV)
 - Car registration and titles
 - Driver's licenses and ID cards
- ☐ Get or replace manufactured and mobilehome (MH-unit) documents – Department of Housing and Community Development (HCD)
 - Registration and title
 - Salvage certificates
- ☐ Replace your property records – LA County Registrar Recorder/County Clerk
- ☐ Replace income tax documents – Franchise Tax Board (FTB)
- ☐ Replace military service records – California Veterans Affairs (CalVet)

Insurance claims

- ☐ Get help with insurance claims – Department of Insurance (CDI)

- Handling delays
- Living expenses
- Underinsurance disputes

Employment

- ☐ If you can't work due to the fires, apply for benefits – Employment Development Department (EDD)
 - State and federal unemployment
 - Disability insurance benefits
 - Job opportunities and training

Taxes

- ☐ Get help with taxes – Franchise Tax Board (FTB)
 - Income tax extensions and filing assistance
 - Address updates
- ☐ Get help with tax relief – LA County Treasurer and Tax Collector (TTC)

Rebuilding help

Business help

- ☐ Get help with business taxes – California Department of Tax and Fee Administration (CDTFA)
 - Sales and use tax
 - Extension to file returns
 - Relief from interest and penalties
- ☐ Get business income tax relief and filing extensions – Franchise Tax Board (FTB)
- ☐ Get employer payroll tax extensions – Employment Development Department (EDD)
